WHEREAS, the Readington-Lebanon Sewerage Authority has the need on a timely basis to replace 500 linear feet of damaged chain link fencing and (2) sliding gates utilizing the State of NJ Cooperative Purchasing contract; and,

WHEREAS, the State of NJ Cooperative Pricing System has awarded a chain link fence install and replacement contract to E.B. Fence LLC, 23 Red Fox Trail, Sicklerville, NJ 08081 Contract# A88679; and,

WHEREAS, *E.B. Fence LLC*. has submitted a proposal indicating they will remove the damaged fence and install a new 6 ft high chain link fence with top rail and barbed wire and (2) sliding gates for \$21,358.32; and,

WHEREAS, the Administrator certifies that the funding source for \$21,358.32 shall be from unrestricted General Fund assets; and,

NOW THEREFORE, BE IT RESOLVED that the governing body of the Readington-Lebanon Sewerage Authority authorizes the Administrator to enter into a contract with E.B. Fence LLC as described herein; and,
