Except as expressly amended by this Addendum, all other terms and conditions of the original BID shall remain in full force and effect.

1. Contractor Requests that the contract price be adjusted annually commensurate with the Consumer Price Index (CPI) rate adjustment for the Waste Haulers / Disposal Index as published by the U.S. Dept of Labor for the Geographic Area where the work is being performed
2. Contractor Requests that the Authority include a quarterly fuel rate adjustment to the contract based on the Fuel Index for On-road Diesel as published by the U.S. Department of Transportation, Division of Highways, Office of Energy Programs Index, for the geographic area where the work is being performed.
3. Will the Authority please provide the prospective bidders with their form contract agreement for review prior to the bid submittal date?
4. If the Authority does not have a form contract agreement, will it consider utilizing the form agreement from the perspective bidder, negotiated to include agreed upon terms and conditions.

## CONTRACT

**THIS AGREEMENT made this the ?? day of ?? 2026, with a one (1) year, three (3) year or five-year (5) contract at the owners option,** between the **READINGTON-LEBANON SEWERAGE AUTHORITY** hereinafter called "OWNER" and **TO BE DETERMINED AFTER BID OPENING** doing business in the State of **NEW JERSEY** hereinafter called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned, to be made and performed by the OWNER, the CONTRACTOR hereby agrees with the OWNER to commence and complete the service described as follows: APPROXIMATELY 20 to 144 ROUND TRIPS TO STONY BROOK REGIONAL SEWERAGE AUTHORITY hereinafter called the 'PROJECT', **for the sum of \$ ??? PER TRIP, TOTAL AMOUNT OF BID: \$ ??? (to be determined by the lowest responsible and responsive bidder)** and all extra work in connection therewith, under the terms as stated in the General Instructions of the Contract and at his (its or their) own proper cost and expense to furnish all the materials, supplies, machinery, equipment, tools, superintendence, labor, insurance, and other accessories and services necessary to complete the said project in accordance with the conditions and prices stated in Proposal, the General Instructions and Special Conditions of the Contract, the plans, which includes all maps, plats, blue prints, and other drawings and printed or written explanatory matter thereof, the specifications and contract documents therefore as prepared by the Administrator and as enumerated in the General Instruction all of which are made a part hereof and collectively evidence and constitute the contract.

The OWNER agrees to pay the CONTRACTOR in current funds for the performance of the Contract, subject to additions and deductions, as provided in the General Instructions of the Contract, and to make payments on account thereof as provided in "Payment" of the General Instructions.
